

# **Privacy Policy:**

Bone Vault Inc. values your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our various apps and website. Please read this Privacy Policy carefully. If you do not agree with the terms of this Privacy Policy, please do not access the App or Site. By using our Service, you agree to the collection and use of information in accordance with this policy.

## 1. Information We Collect

#### 1.1 Personal Information

We may collect personal information that you provide to us when using our App and Site, including but not limited to:

- Name
- Email address
- Account credentials
- Contact information

#### 1.2 Usage Data

We may collect information about how the App and Site are accessed and used ("Usage Data"). This Usage Data may include information such as:

- Device type
- IP address
- Browser type
- Pages visited
- Time and date of visit
- Time spent on pages
- Other diagnostic data

#### 1.3 Email Data

With your explicit consent, we may access your email data to provide the email cleanup services. This may include:

- Email headers (sender, recipient, subject, date, etc.)
- Email content (only as required to perform the cleanup tasks)
- Email attachments (if applicable)

## 2. How We Use Your Information

We may use the information we collect for various purposes, including to:

- Provide, operate, and maintain the App and Site
- Improve, personalize, and expand the App and Site
- Understand and analyze how you use the App and Site
- Develop new products, services, features,

# 3. Sharing Your Information

We do not sell, trade, or otherwise transfer your Personal Information to outside parties except as described in this policy:

- Service Providers: We may employ third-party companies and individuals to facilitate our Service, provide the Service on our behalf, perform Service-related services, or assist us in analyzing how our Service is used.
- Legal Requirements: We may disclose your Personal Information if required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).

# 4. Security of Your Information

We take reasonable measures to help protect your Personal Information from unauthorized access, use, or disclosure. However, no method of transmission over the internet, or method of electronic storage, is 100% secure.

## 4.1 Data Protection Rights

Depending on your location, you may have the following rights regarding your Personal Information:

- Access: The right to access and receive a copy of the information we hold about you.
- Rectification: The right to request that we correct any information you believe is inaccurate or incomplete.
- Erasure: The right to request that we erase your Personal Information, under certain conditions.
- Restriction of Processing: The right to request that we restrict the processing of your Personal Information, under certain conditions.
- Data Portability: The right to request that we transfer the data we have collected to another organization, or directly to you, under certain conditions.
